The Committee met with the Finance Committee to request \$60,000 in revenue sharing funds for the Highway Department.

MACOUPIN COUNTY PLANNING COMMISSION MINUTES

Meeting was called to order at 7:30 P. M. by Secretary, Bill McAllister, in the absence of Chairman Hagerman. Minutes of the previous meeting were read and approved. Roll call showed 6 members present and 6 exofficio members present, with guest Beth Brase, Macoupin County Public Health Department.

The final plat of Lorrhoam Estates was presented for approval. Letters of opposition from Mrs. Laura Feleermann and Lloyd Stinnett were reviewed. Both voiced opposition because of the influence the subdivision might have on their farming operations or their traditional home environment. Since the County has no standards or policy on land use to avoid or resolve conflicting uses, these concerns could carry little or no weight on the subdivision approval. Tom Gazda reported all provisions of the ordinance were being met. Bonding procedure alternative through the bank was acceptable. Motion by Jim Denby, seconded by Dick Lounsberry, that the subdivision plat be recommended for approval to the County Board.

McAllister announced that the University of Illinois and cooperating junior colleges were again working on training programs for county board members. The first will be November 8, with emphasis on new board orientation. More information will follow.

The Agriculture Areas Conservation and Protection Act of Illinois was discussed. The law allows one or more farmers with a block of 500 or more ac res of land to petition the County Board to designate that land an Agriculture Area under the act. The purpose of the law is to allow farmland owners to voluntarily set aside their land, be protected from nuisance complaints or law suits against farming operations, and let local officials and the public know that they are serious about preserving their farmland. After much discussion there was found to be few reasons that the County Board would not accept one of these petitions. Inquiry has been made from the Benld area, with other inquiries from Brighton and the Virden/Girard areas.

A follow-up review of the Farmland Protection Ordinance resulted in mixed assessments. Board members indicated that constituents simply did not want any further government regulations or loss of rights. Some others felt that the voices heard were not representative of farmers and true review of the actual ordinance was not received. The right of landowners to know and receive protection from changes in their community is still needed as is the need to preserve prime farmland.

McAllister pointed out to the County Board Planning Committee that the Ordinance Commission had spent over 350 man hours of volunteer time. They had worked long and hard in putting together and carrying out this ordinance for the County Board. Although they were not allowed to complete their project, they were due recognition and gratitude from the County Board.

A question on the future role of the County Planning Commission was raised. It was felt that it should continue, but that the County Board must give further direction to their role and

The Planning Commission year ends in June and a review of the membership terms found the following Districts subject to Board action: District 1 - vacant; District 5 - poor attendance; District 8 - Dick Lounsberry accepted by reappointment; District 7 - vacant; District 2 vacant; District 3 - poor attendance.

Following the Board's appointments, the Commission will elect officers at a later meeting.

WHEREAS, the cost of the participating construction portion of this off-system road district project is estimated at 115,500 and,

WHEREAS, State "Township Bridge Program Funds" administered by the COUNTY will pay 80% of the said participating construction costs, right-of-way costs, utility relocation costs and construction engineering costs, and,

WHEREAS, Preliminary engineering costs have been assessed in accordance with an agreement dated 8 June 1982 and,

WHEREAS, a total of 10,000 is estimated costs for right-of-way and utility relocations costs and 7,500 for construction engineering costs,

COUNTY BLANKET PERMIT (INTER CITY COMMUNICATIONS UTILITY) COUNTY OF MACOUPIN, STATE OF ILLINO:

THIS BLANKET PERMIT made this August 14, 1984 for UNITED TELECOM COMMUNICATIONS, INC. Box 11315, Kansas City, Missouri (hereinafter designated "COMPANY") by COUNTY BOARD OF MACOUP! COUNTY hereinafter designated "COUNTY"), for a period of twenty (20) years after the date of permit.

THIS AGREEMENT made this August 14, 1984 between the County Board of Macoupin County, State of Illinois, (herein designated "COUNTY") and UNITED TELECOM COMMUNICATIONS, INC., Box 11315, Kansas City, Missouri, its successors and assigns (herein designated "COMPANY") for a period of twenty (20) years after the date of the agreement.

WITNESSETH: THAT

WHEREAS, United Telecom Communications, Inc. has petitioned this County Board for permission to construct, operate and maintain an inter-city communications line with the necessary wires cables, fixtures and appurtenances, along, under and across roads in the Countyof Macuupin, State of Illinois, over which this County Board has now or may in the future have jurisdiction

THEREFORE, BE IT RESOLVED, by the County Board that the United Telecom Communications, Inc. be and is hereby granted permission to construct, relocate, operate and maintain an inter-city communications facility on, over, along, across, and/or under the highway within the right-of-way limits of any County Highway in Macoupin County, State of Illinois, over which this County Board has jurisdiction, provided that the facility is so constructed and located to meet the approval of the County Superintendent of Highways, also provided a permit request and attached plat showing the location of each proposed project, shall be submitted by the Company to the County Superintendent of Highways at a time he requests but not later than two weeks before the start of any construction and a permit for said construction shall be issued by the County Superintendent of Highways.

Blanket permit, agreement, and permit for County Superintendent of Highways are subject to the

1. The permit sent to the County Superintendent of Highways shall include a drawing and form from the Company showing the size, type, location, nature and extnet of utility company facilities being located within or along highway right-of-way.

following terms and conditions, namely:

- 2. The Company shall furnish to the County Superintendent adequate drawings or sketches with the permit application showing the existing and/or proposed location of the utility company facilities within or along the highway right-of-way with respect to the planned highway improvement or existing highway, and show the right-of-way lines.
- 3. The Company shall be liable for the cost of adjustments or changes in the location or type of any existing facility or facilities now located or hereafter constructed on highway right-of-way which adjustments or changes are necessitated by highway construction or maintenance.
- 4. The Company shall comply with all applicable County, State and Federal Laws and all applicable codes.
- 5. The utility company facilities to be retained, installed, adjusted or relocated on, over, along or under the highway within or along the right-of-way limits will be located and accommondated in a manner that will not impair the highway or the planned highway, or its construction, or maintenance, or in-erfere with its safe operation, and should any damage occur to the highway through the action of the Company, it shall be repaired by the Company in a manner satisfactory to the County Superintendent of Highways.
- 6. Suitable arrangements shall be made between the Utility Company and County Superintendent of Highways for accomplishing, scheduling and completing the utility work, for the disposition of any facilities to be removed from or abandoned within the highway right-of-way, and for the proper coordination of such activities with planned highway construction. Such arrangements should be made at the earliest feasible date in advance of planned highway construction.
- 7. All installations under any pavement of concrete, brick built up asphalt or bituminously treated surface shall be made by boring.
- 8. In the event any facilities are extended or if the location of said facilities or lines be altered, or if a variance from the provisions of this permit be made, a written permit shall be obtained by the Company from the County Superintendent of Highways.
- 9. The Company shall assume all risks and liabilities of any kind or nature occurring from, either during construction of said inter-city communications facility or resulting therefrom, or from the installation, operation or maintenance of said facility and the Company shall indemnify, protect and save harmless the County and County Superintendent of Highways from all claims of every kind and character which arise out of, are based upon, or claimed to have arisen out of the construction, installation, operation and maintenance done by the Company or any of its agents, employees, contractors, or subcontractors pursuant to this agreement. Company liability shall extend beyond time limits of this agreement if Company is still in operation or its facilities remain on county highway right-of-way, or until new agreement is executed.
- 10. 10. The Company shall take all necessary precautions by use of signs, signals, flagmen, or watchmen to protect the general public and all reasonable measures to cause least interference with traffic movement along the highway where construction or maintenance is in progress. All traffic control shall be in accordance with the current State of Illinois "Manual of Uniform Traffic Control Devices" and amendments thereof,
- 11. The Company shall furnish all materials, do all work, and pay all costs involved on said construction, relocation, operation and maintenance of its facilities on the county right-of-way, including those costs for damages to the highway.
- 12. Company shall indemnify the County and County Superintendent of Highways from all liability for interference or damage in any manner with other utilities in, along, under, or upon said highways during work pursuant to this blanket permit.
- 13. This Blanket Permit is issued to the Company with the understanding that any damage to properties abutting said County Highways caused by construction, operation, or maintenance of said utility facilities shall be promptly repaired to original condition and/or paid for if necessary.
- 14. If any drain tile is encountered, the County Superintendent of Highways shall be notified thereof in writing, and such drain tile shall be restored and replaced at its original elevation.
- 15. Upon completion of construction, the grade of any roadway ditch shall be restored as closely as practicable, to its present condition. Culverts and tiles shall be restored, as closely as practical to their present condition.
