A Risk Needs Assessment classification system will be made on a person coming into Probation. This will make it easier for supervision and transfer of cases. Also, effective April 1st the State will fund the salary of the Chief Probation Officer 100% with the County paying expenses and benefits. Re: Collective Bargaining in County Government: Developments Under the New Law

Dear Mr. Jubelt:

As you know the state has recently enacted the "Illinois Public Labor Relations Act" which applies to all county governments having twenty-five or more "employees" as defined in the Act. Since employees of sheriff's departments, and managers and supervisors among others, are not employees within the meaning of the Act, many county governments will not, at present, £all under the Act's coverage.

However, it seems reasonable to expect that in the years to come, the legislature will lower that threshold and/or will include employees of sheriff's departments under the Act's coverage. In that event counties not presently covered will come under the Act.

In any event, prior to the effective date of the Act, July 1, 1984, the University of Illinois Institute of Labor and Industrial Relations Management Education Program is conducting a series of one day seminars designed for specific governmental units, such as elementary and secondary school districts, counties and county highway departments, municipalities with populations from 25,000 to 150,000, park districts, library districts, etc.

Each such seminar is designed to address the specific concerns and the particular kind of governmental unit concerned. Enrollment is limited so that no more than approximately thirty-five participants are in each session. This is to permit a maximum amount of participation and questions from those who attend. Instruction is provided by professionals who have considerable experience as practitioners as well as academic training and credentials in the field of public sector labor relations.
