Minutes

Motion by Pomatto, seconded by Coatney, to approve the minutes of the March 14, 2006 meeting. All in favor, motion carried.

Guests

Kent Tarro, Administrator, Public Health Department, advised the Board of the Senior Health Services that will be held throughout Macoupin County on Tuesday, April 18 at St. Patrick's Hall in Girard, Thursday, May 4 at Brighton Municipal Building, Tuesday, May 9 at Gillespie Civic Center, Tuesday May 16 at the Mt. Olive Church of the Ascension and Thursday, May 18 at the Staunton VFW. There is a \$5 fee for the services.

Ruth Brooks from Brighton presented the Board members with a petition and information regarding the noise from an ATV track near her home. After much discussion, there was a motion to refer the matter to the Planning and Subdivision Committee.

Josh Koehne, of Bunker Hill, was recognized with a certificate from Chairman Manar for reaching the rank of Eagle Scout.

Committee Reports

Coatney, Chairman of the **Sheriffs Building and Grounds Committee** read the minutes of the meeting held on February 22, 2006. Sheriff Albrecht notified the Committee that the Animal Control Warden had resigned effective February 28th. The Committee recommended the position be posted according to the union requirements. Motion by Coatney, seconded by Harding to approve the minutes as reported. All in favor, motion carried.

Bacon, Chairperson of the **Planning and Subdivision Committee**, read the minutes of the March 2, 2003 meeting. The Committee discussed the Sunset Acres Subdivision in Bunker Hill Township and Flag Lots. Bacon noted the minutes should have Sunset Acres Subdivision not "Sunset Lake." The Committee tabled approval of the Sunset Acres Subdivision in Bunker Hill Township. Assistant State's Attorney Brent Cain advised the Committee that there is nothing in the Illinois Statutes regarding "flag" lots. Motion by Bacon, seconded by Wiggins, to approve the minutes as read. Goodman, Chairperson of the **Road and Bridge Committee**, read the minutes of the March 7, 2006 meeting. The Committee approved claims totaling \$66,365.80. Goodman informed the Committee of a request concerning Stults Cemetery and Brookview Road in Barr Township. The Committee agreed to refer the matter to the appropriate committee. Reinhart informed the committee that Brookview Road is a township road. Motion by Goodman, seconded by Wieseman, to approve the minutes as read. All in favor, motion carried.

Motion by Jubelt, seconded by Thomas, to appoint David W. Hartke and Edward Becker to the Mt. Olive Fire Protection District Board of Trustees effective February 15, 2006.

Manar distributed a copy of the DCEO Newsletter to each of the members.

A letter from the United States Department of the Interior regarding the National Park Service Route 66 Corridor Preservation Program announcing the cost-share grant application cycle is now open.

Manar informed the Board of a letter sent by Judge Koval to the Attorney General's office and Sheriff Albrecht regarding the booking fees instituted by the County Board.
