Discuss the re-issuance of a Liquor License to the Full Throttle Thursday, Inc.

The meeting was called to order at 10:30 by Committee Member Zirkelback. The Committee discussed, at length, the complaints regarding the Full Throttle Thursday, Inc. Ms. Johnston was not present during this conversation. The Members were given a copy of a letter, from Ms. Johnston, regarding the complaints of her establishment. In the letter, it was noted that the bar is open 90 hours per week and a band entertains 4 hours per week – from 9:00 p.m. to 1:00 a.m.

When Ms. Johnston was brought into the meeting, a very lengthy discussion was held. The County has no Ordinance regarding the loud noise, but the Sheriff's Department has logged several complaints regarding this establishment. It was suggested that perhaps changing the band hours from 8:00 p.m. to 12:00 a.m. as well as moving the band inside may be a solution to the problem of the extremely loud music. Ms. Johnston agreed to try to alleviate the noise problem, and the following motion was made:
