The **Animal Control Committee** met on April 29, 2008. The Committee recommended for approval by the full Board the adoption of the changes in the Animal Control Ordinance. The Committee recommended for approval by the full Board the location of the future Animal Control Shelter to the north side of the Highway Department. Bertagnolli advised the Committee, she received two resumes for part-time Animal Control officer on an as needed basis and Brian Carver was selected. The **Economic Development Committee** met on April 30, 2008 to discuss a revolving loan fund application. The Committee approved for recommendation by the full Board a loan from the Macoupin County Revolving Loan Fund to Alltype Hydraulics in the amount of \$35,000.
