Both the House and Senate adjourned last night (9/23/08). While Monday was mostly spent idly spinning wheels, Tuesday saw Legislators get around to more substantial work. The Senate manage to concur with the House on both the Fund Sweeps Bill (SB 790) and an attached appropriations Bill (SB 1103) – the House having passed these the last time they convened to restore cuts to State Parks and other programs made by the Governor. These bills will now be sent to the Governor where they will wait for him to act upon them.

The Senate also voted to pass an ethics bill (SB 780) which contained the Governor's exact language from his earlier amendatory veto of the ethics bill, which was rejected earlier. Needless to say, this caused some sparks to fly. The return of another hot issue was Senator DeLeo's Autism bill (HB 2070), which passed the Senate but not with a fair amount of grandstanding. Earlier this month, the House rejected the Governor's Amendatory Veto language which was similar to the language in HB 2070. Meanwhile the House voted to accept a number of the Governor's Amendatory Vetoes, including the Governor's changes to the ALL KIDS audit. The following is a list of bills which were voted on in the Illinois General Assembly by one chamber or both.

Bills passed by the Senate and sent to the House

HB 2070 Autism Coverage Bill Passed Senate

Amends the Counties Code to provide individuals under 21 years of age coverage for autism spectrum disorders. Provides that this coverage shall be subject to a maximum benefit of \$36,000 per year, but shall not be subject to any limits on the number of visits to an autism service provider.

SB 780 Ethics Bill Passed Senate

Prohibits members of the General Assembly from being employed by the State, a municipality, or a unit of local government, with specified exceptions. Contains all of the Governor's amendatory veto language that was brought up for a vote in the Senate this week.

House Bill 824 now law... On Monday, the Senate overrode the Governor's amendatory veto of HB 824, the campaign funding reform legislation. The House took the same action last week. The new law bans businesses with more than \$50,000 in state contracts from making political donations to constitutional officers who award the contracts. The bill will become law on January 1, 2009.
