COMMITTEE REPORTS

The **Finance Committee** met on March 22, 2011. The Committee met to for the purpose of an updated on the Elections Budget, Special Audit presentation, letter to the city of Carlinville re: Municipal elections, health reimbursement account, RLF resolution amendment, Animal Control grant from the State of Illinois, proposal to lease copy equipment in the Board office, and reolution transferring funds to the Grant fund. The Committee moved to report the special audit to the full Board. The Committee tabled discussion of the Health Reimbursement Accounts and Letter to the City of Carlinville until the next meeting of the Finance committee due to Clerk Duncan not being present due to election judge training. The Committee recommended to the full Board the Revolving Loan Fund Resolution amendments. The Committee recommended to the full Board a resolution transferring funds to the Grant Fund to account for the interest for the Animal Control grant. The Committee also directed CFO Springer to execute the lease with Ikon for a new copy machine. Motion by Pomatto, seconded by Thomas to approve the minutes as

The **Animal Control Committee** met on April 4, 2011. The Committee met to discuss the new building, personnel, review current bills and discuss any other related business. The committee recommended to the full board the approval of payment to Neely Construction in the amount of \$71,228.52 pending the receipt of all permits for the building. The **Executive Committee** met on April 4, 2011. The Committee met to approve timesheets, resolution to post contracts online, approve the agenda for the April meeting, approve the RFL Quarterly and Monthly report, and an executive session to discuss personnel.
