Motion by Wieseman, seconded by Quarton, to approve the minutes of the April 12, 2011, meeting with changes. All in favor, motion carried.

COMMITTEE REPORTS

The **Finance Committee** met on April 13, 2011. The Committee met to for the purpose of a request to increase Animal Control loan; 5% budget proposals; State’s Attorney Office Reimbursement Request; County Contribution in State’s Attorney Appellate Prosecutor Program; Letter to City of Carlinville Re: Municipal Elections; Health Reimbursement Account. The Committee recommended to the full Board a resolution to participate in the service program of the Office of the State’s Attorney Appellate Prosecutor for FY 2011. The Committee recommended to the Board to pay \$13,000.00 for participation in the Office of the State’s Attorneys Appellate Prosecutor Program for FY 2011. The Committee directed the Chief Financial Officer to work with the County Clerk, Health Department, and Highway Department to develop a temporary solution concerning the HRA account and its payments to employees and Benefit Planning Consultants. The Committee also voted to send a letter to the city of Carlinville regarding looking at options to reduce costs for the city’s municipal elections. Motion by Thomas, seconded by Coatney to approve the minutes as written. All in favor, motion carried.

The **Executive Committee** met on April 19, 2011. The Committee met for the purpose of

background on County Board redistricting process in state statute, review population statistics from the 2010 Census provided by the U.S. Census Bureau, review results of the public referendum from the November 2008 General Election, and public comment. Motion by Reiher, seconded by Quarton to approve the minutes as written. All in favor, motion carried.

The **Executive Committee** met on April 25, 2011. The Committee met for the purpose of background on County Board redistricting process in state statute, review population statistics from the 2010 Census provided by the U.S. Census Bureau, review results of the public referendum from the November 2008 General Election, and public comment. Motion by Quirk, seconded by Quarton to approve the minutes as written. All in favor, motion carried.

The **Finance Committee** met on April 13, 2011. The Committee met to for the purpose of discussion on the FY 10-11 budget, State's Attorney's Office Reimbursement, Revolving Loan Collection Update, Animal Control Loan, Health Reimbursement Account, Real Estate Transfer Fund, Lease Payment Resolution, Civil Union Fees. The Committee recommended to the full board an increase in the State's Attorney's appropriation by \$7,077.10, reducing the Real Estate Stamps line 17 by \$41,000.00 and increase Elections Line 12 by \$41,000.00 and to increase appropriations to the Tax Assessments/Collections by \$8,000.00. The Committee recommended to reduce the appropriations on the line items that can be reduced by 5% effective by the May Board Meeting. The Committee recommended to the Board to adopt a resolution to increase the Macoupin County Probation General Fund and Probation Fee Fund Budgets. The Committee recommended to the Board a resolution regarding the financing of the Animal Control Loan. The Committee recommended to the Board a resolution regarding lease payments. Motion by Harding, seconded by Coatney to approve the minutes as written. All in favor, motion carried.

The **Animal Control Committee** met on April 27, 2011. The Committee met to review the final bills and discuss any other related business. The committee recommended to the full board the approval of payment to Neely Construction in the amount of \$21,290.18. Motion by Pomatto, seconded by Wiggins to approve the minutes as written. All in Favor. Motion Carried.

The **Road and Bridge Committee** met on May 3, 2011. The Committee met to review the final bills and discuss any other related business. The committee recommended to the full board the approval of the construction engineering agreement in an amount not to exceed \$16,625.10 with Cummins Engineering Corporation for the Shipman Cutoff Road soil-cement project.. The Committee also moved to accept bids and recommend to the full Board award contracts to the low bidders. Motion by Goodman, seconded by Nichelson, G. to approve the minutes as written. All in Favor. Motion Carried.

The **Executive Committee** met on May 3, 2011. The Committee met to approve timesheets, approve agenda for the May 2011 meeting of the Macoupin County Board and the Revolving Loan Fund Monthly Report – April.. The Committee approved the April 2011 time sheets for non-union personnel. The Committee approved with additions the agenda for the May 2011 County Board Meeting. Motion by Coatney, seconded by Bacon to approve the minutes as written. All in Favor. Motion Carried.
