

Note2: As of today's report date, a new agreement has been made with David and Patty Ambrose (Connexus) and terms were re-negotiated into a new note due a change in employment status. The new note takes effect in April 2012 once signed with first payment due 4/10/12.

Note3: A \$10,000.00 loan at 3% interest / one-pay note to the Mercantile Center (formerly listed with a separate, current loan under R&A Enterprises) was approved by the County Board at its December 2011 meeting. Per terms of the note, the Mercantile Center is required to appear before the County Board's Economic Development Committee to provide appropriate financial updates and foreclosures in the event the loan has not yet been prepaid. Repayment of the single-pay note is due no later than January 1, 2013.

Dear County Board Chairman:

Enclosed please find a copy of the Illinois Noxious Weed Law (505 ILCS 100/1 et seq.) and associated regulations. Under its provisions, the governing body of each county is designated as a *Control Authority* and is to do the following:

- 1) establish a coordinated program for control and eradication of noxious weeds within the county;
- 2) conduct an examination of all land under its jurisdiction for compliance with the Act; 3) compile data on infested areas and areas eradicated;
- 4) advise persons responsible for controlling and eradicating noxious weeds of the best and most practical methods of noxious weed control and eradication;
- 5) investigate or aid in the investigation and prosecution of violations of the Act;
- 6) publish notices for control and eradication of noxious weeds as set forth in the Act and these rules and as prescribed by the Director; and
- 7) cooperate with Federal, State, and local authorities in carrying out the provisions of the Act and its rules.

Control Authorities may employ one or more weed control superintendents who must be certified by the Director of the Illinois Department of Agriculture to carry out many of the various activities authorized in the Act including the examination of lands under the Control Authority's jurisdiction, the investigation of complaints, the issuance of control notices, and the creation and submittal of an annual report.

Please take a few minutes and review the enclosed statute and regulations, the status of your current noxious weed control program, and whether improvements might be made to improve its effectiveness. If you have any questions or comments, please feel free to contact us at the Department of Agriculture at your convenience.



RE: Historic Route 66 Bike Trail Staunton, IL. to Mt. Olive, IL.

Dear Mr. Driskell:

Macoupin County in cooperation with the City of Staunton, City of Mt. Olive, Mt. Olive Township, Staunton Township, the Illinois Traction System Trail Committee, the Route 66 Trail Executive Council, and the Illinois Department of Natural Resources has been working to begin the process of developing a new Bike Trail as described above. This would be a northern extension of the existing trail currently ending in Staunton, Illinois. That existing trail, of course, is part of the Madison County Bike Trail system which connects to the Metro-St. Louis System and beyond. This proposed project would be the next step in extending the trail system along the Old Route 66 corridor all the way to Chicago.

On March 15, 2012, representatives from the above group met with several staff members from District 6 along with Mr. Todd Hill, Statewide Bicycle and Pedestrian Coordinator to discuss this proposed project and explore funding options available for the project along with the local matching share costs that may be involved. As proposed by our group, it was agreed that the current round of ITEP funding would be a very logical source of primary funding. Macoupin County would be the lead agency for such an application. With ITEP providing approximately 80% of the funds required, this would leave the 20% for a local match.

This brings us to the reason for this letter. In the above referenced meeting, the question came up regarding the possible Jurisdictional Transfer (JT) of that portion of the Old Route 66 right-of-way to be used in the proposed project. The funds provided by the State for said JT could then be used as the local share of the project. We, therefore, request that the possibility of executing this JT be reviewed as soon as possible by your staff for the purpose of making an application for the ITEP funding during this current round. This information will help us determine the ability for us to move forward with the ITEP grant application. The staff members present would have project specific information from the meeting to complete such a review.

We, of course, would be happy to provide any additional information required.
