SCOPE OF WORK

Acquire the additional right-of-way and temporary easements required for the proposed improvement of the Emmerson Airline Road from the Carlinville Cutoff Road, CH 36, to the west edge of Girard near the Pleasant Hill Road/Rachel Road, a distance of approximately 4 miles.

There are 17 parcels with 15 property owners.

Items of Work (Construction)

- Review Wavier Valuations prepared by Macoupin County Highway Department.
- 2. Prepare introductory letters and offer letters for the property owners.
- 3. Set up meetings with property owners to discuss the proposed project and the additional right-of-way needed from their property to construct the project in accordance with the plans. The negotiator will have a complete set of plans available to show the property owners. The offer will be made to the property owners. This offer will be based upon the approved Wavier Valuation.
- 4. The negotiator will keep notes of the meetings with the property owners.
- 5. Prepare the necessary documents to acquire the needed right-of-way and/or temporary easements. These documents will be recorded.
- 6. Prepare a Receipt for Deed to be left with the property owners. This document will indicate the compensation due the property owners.
- 7. Deliver the signed documents to the County Engineer along the "Request for a Check to be Issued" to pay the property owners.
- 8. Prepare a Parcel Compliance Checklist.
- 9. At the completion of the right-of-way acquisitions, prepare a Project Compliance Checklist.
- 10. Take the right-of-way files to IDOT Land Acquisition for approval. IDOT approval of the right-of-way acquisition is required before the project can be bid.
