A Resolution Establishing Supplemental Appropriations from the General Fund for Fiscal Year 2012-2013

WHEREAS, the Macoupin County Board is responsible for developing an annual budget for the offices and departments in County government; and

WHEREAS, the Public Services Committee met on April 3, 2013 to discuss the need to commit funding for the North Stair Courthouse Renovation project associated with a 1:1 matching grant received from Landmarks Illinois; and

WHEREAS, the total cost of the North Stair Courthouse renovation project is expected to amount to approximately \$200,000; and

WHEREAS, the grant received through Landmarks Illinois may require the County to pay for costs of the project upfront before receiving grant funds at a 1:1 match rate; and

WHEREAS, once matching funds are received from Landmarks Illinois, the County will deposit the funds in the General Fund to reimburse expenses previously made by the County; and

WHEREAS, the Public Services also previously met on March 6, 2013, to discuss the Tax Assessment and Collection line budget and subsequently recommended to the full board an increase of \$20,000 of which \$15,000 will come from a transfer from the Tax Sale in Error Interest Fee Fund; therefore

BE IT RESOLVED, the Macoupin County Board establishes supplemental appropriations for the Fiscal Year 2012-2013 general fund budget totaling \$6,720,174 as enumerated below, with amendments to the "Capital Outlay" line for purposes of paying for costs related to the North Stair Courthouse Renovation project and to the "Tax Assessment and Collection" line for purposes of preparation and mailing of the tax bills; and

BE IT FURTHER RESOLVED, that the appropriation for each office/department shall be effective for the period of September 1, 2012 through August 31, 2013.
