A Resolution Establishing a Declaration to Vacate Part of Subdivision Plat of the Carl Mueller's Subdivision, Macoupin County, Illinois

WHEREAS, there was filed for record in the Office of the Recorder of Deeds of Macoupin County, Illinois, on April 27, 1905, a Plat designated as Carl Mueller's Subdivision of the South Half of the Southeast Quarter of the Southwest Quarter of Section 3, Township 7 North, Range 6 West of the Third Principal Meridian, Macoupin County, Illinois, said Plat being dated April 22, 1905, AND:

WHEREAS, the said Carl Mueller did own and was possessed of the fee simple title to said property as so platted and which Plat does include certain dedicated right of ways for street purposes and public grounds running North and South and running East and West through said Plat, AND:

WHEREAS, George J. Kuchar, is now the owner of all that part of Block 5 lying east of Old Route 66 (F.A.I. Route 5) and all of Block 6 and the West Half of Block 7 in the said Carl Mueller's Subdivision by virtue of a Warranty Deed recorded in the Office of the Recorder of Deeds of Macoupin County, Illinois, AND that running North and South between the said Blocks 5,6, and 7, AND that running East and West along and adjacent to the north side of said Blocks 5, 6 and 7 of said Carl Mueller's Subdivision are certain dedicated right of ways for street purposes and public grounds, AND:

WHEREAS, the said dedicated right of ways for street purposes and public grounds as above mentioned as running between the said Blocks 5, 6 and 7 as running along and adjacent to the north side of the said Blocks 5, 6 and 7, have never since said Plat was filed for record, been appropriated for public use and in fact, that there are no such streets in actual and visible existence, and that an abandonment of said dedicated right of ways, as mentioned above, will not operate to prejudice any owners of any other portion of the Plat, AND:

WHEREAS, there is attached hereto, and made part of, a "Plat of Vacation" describing the limits of the said dedicated right of ways and portions thereof to be vacated, AND:

WHEREAS, George J. Kuchar desires to vacate all that part of the 40 feet wide dedicated right of ways running North and South between the said Blocks 5, 6 and 7, beginning at the south line of the said Blocks 5, 6 and 7 and ending at the north line of the said Blocks 5, 6 and 7 AND to vacate all that part of the 20 feet wide dedicated right of way running East and West along and adjacent to the north side of said Block 5 that lies east of Old Route 66 (F.A.L Route 5) and continuing East along and adjacent to the north side of the West half of

said Block 7 and including all that part of the said 20 feet wide dedicated right of way extending across the North and South 40 feet wide dedicated right of ways between the said Blocks 5, 6 and 7.

Kuchar to vacate all that part of the 40 feet wide dedicated right of ways running North and South between the said Blocks 5, 6 and 7, beginning at the south line of the said Blocks 5,6 and 7 and ending at the north line of the said Blocks 5, 6 and 7 AND to vacate all that part of the 20 feet wide dedicated right of way running East and West along and adjacent to the north side of said Block 5 that lies east of Old Route 66 (F.A.I. Route 5) and continuing East along and adjacent to the north side of said Block 6 and along and adjacent to the north side of the West Half of said Block 7 and including all that part of the said 20 feet wide dedicated right of way extending across the North and South 40 feet wide dedicated right of ways between the said Blocks 5, 6 and 7, is hereby vacated from this day forward, AND with the approval of the County Board of Macoupin County, Illinois, and that from this day forward, the above described portions of the said Carl Mueller's Subdivision is hereby vacated.
