

UPCOMING VEGETATION ACTIVITIES NOTIFICATION

Please be advised that Ameren will perform vegetation management in your community in the near future. Our professional vegetation management specialists will be managing vegetation on rights-ofway that could affect our electric lines. This vegetation management work is necessary to protect the integrity of the electric system and to prevent potential safety hazards.

This work might include: aerial or manual trimming, removal of vegetation, mowing, application of environmentally-safe herbicides, and inspections, as necessary in your community. Common addresses of properties affected by this planned vegetation management in your area are provided with

this letter to be available for those affected to review. You may receive calls from residents inquiring
about these vegetation work locations because our notification letters to the residents inform them that
the list of addresses has been provided to your office. Illinois Statute requires us to provide this list to
you and to advise the residents that the list has been provided to you. Customers and property owners
