ANNUAL MEETING OF THE MACOUPIN COUNTY BOARD

MINUTES

SEPTEMBER 12, 2006

The Annual meeting of the Macoupin County Board was called to order Tuesday, September 12, 2006, at 1:00 p.m. The meeting opened with the Pledge of Allegiance to the Flag. There were twenty-six members present and one absent.

MINUTES

Motion by Coatney, seconded by Harding, to approve the minutes of the July 11, 2006 meeting. All in favor, motion carried.

GUESTS

Kent Tarro, Public Health Department, discussed the possibility of a global flu epidemic and a new virus. When the bird flu hits, in 15-24 year old persons it attacks their own bodies and kills them. The Public Health Department will be holding their first flu clinics on Saturday October 21, 2006, from 9:00 a.m. to 2:00 p.m. in Carlinville, Girard and Gillespie, Illinois they hope to give 2,500 immunizations the first day. On Friday, October 20, 2006, shots will be given at the Illinois Extension Service in Carlinville, Illinois from 10:00 – 11:30 a.m. for State Police, Firefighters, County Sheriff's Department, County Board members and all County employees.

Tosha Cantrall from the Illinois Extension Office introduced Audra Glenn who has been a 4-H member for ten years. Audra told the Board that her great, great, great, grandfather W. B. Otwell was one of the founders of 4-H in Carlinville. Audra told the Board that she had participated in several classes provided by 4-H including: public speaking, electricity, woodworking, sewing, cooking, and many more. Audra requested Board Chairman Manar to execute a Proclamation designating October 1-7, 2006, as 4-H week in Macoupin County.

COMMITTEE REPORTS

Goodman read the minutes of the August 18, 2006, **Road and Bridge Committee** meeting. The bid was awarded for the Brushy Mound Township project to Yamnitz & Associates, Fieldon, Illinois. Motion by Goodman, seconded by Wieseman, to approve minutes as written. All in favor, motion carried.

Thomas reviewed the minutes of the August 21, 2006, **Grievance Committee** meeting. The Committee went into Executive Session to discuss pending litigation. When the Committee returned to regular session there was a motion by Pomatto, seconded by Schwallenstecker, to proceed with a settlement offer from the County Board to AFSCME as outlined by Mr. Knuppel and Ms. Austis. The settlement offer includes full reinstatement for the terminated employee and full back pay. The employees' employment file will contain a letter of discipline and the employee will be assigned to different duties within the County Clerk's office. Motion by Thomas, seconded by Vojas, to approve minutes as reported. All in favor, motion carried.

Pratt read the minutes of the August 24, 2006, **Legislation Committee** meeting. Larry McDaniel addressed the Committee regarding the need for a person to assess property in the County, since some townships are without an assessor. McDaniel reported that this will help the County's tax rolls and revenue that will be brought into the County. Experience and duties of this position include: assist township assessors, assist Board of Review, property record cards, Geographic Information System, splits, new subdivisions, Plat Officer; experience in reading legal descriptions, read maps, Plat Act, valuation, drafting, and must have passed basic assessment course within a year or have designation approved by DOR. It was decided that since McDaniel's employees are covered by the AFSCME Union, if agreeable with the contract, this should be a non-union position. The Committee voted the title of the new position would be Field Assessment Officer and the employee would be reimbursed for their mileage. Economic Development Coordinator had met with web designer and they are getting closer to completing the newly designed website which should be up and running within a couple of months. Feuquay also reported she had spoken to a representative of the State's Central Management Services regarding a program to improve broad band in Macoupin and Montgomery Counties and the effect it will have on economic development. Motion by Pratt, seconded by Bacon, to approve the minutes as written. All in favor, motion carried.

Goodman read the minutes of the September 5, 2006, **Road and Bridge Committee** meeting. Claims were approved for payment. Three 50/50 Petitions were approved for recommendation to the full Board: Nilwood #27; North Otter #41; and North Otter #42. Four Resolutions were also approved to recommend to the full Board:

Resolution to appropriate \$172,300.00 in Motor Fuel Tax funds for Preliminary Engineering Services on the Litchfield Road project (Section 06-00086-00-PV).

Resolution to appropriate \$150,000.00 in Motor Fuel Tax funds for the local share of Preliminary Engineering Services on the Brighton-Bunker Hill Road project (Section 01-00080-00-FP).

Resolution to appropriate \$85,000.00 in Motor Fuel Tax funds for Preliminary Engineering Services on the Richie Road Major Bridge Project (Section 01-00081-00-BR).

Resolution to appropriate \$62,356.00 in Motor Fuel Tax funds for payment of workers compensation insurance. (Section 06-00000-00-MS).

Motion by Goodman, seconded by Jubelt, to approve the minutes as written. All in favor, motion carried.

Bacon read the minutes of the September 6, 2006 **Planning and Subdivision Committee** meeting. Aaron Hutson presented and discussed Coop's Creek Minor Subdivision in Hilyard Township. Dan McCandless, Resource Conservationist of Macoupin County Soil and Water Conservation District, submitted a copy of his opinion letter which is required as part of the application for a minor subdivision. McCandless felt their property was not suitable for a home septic system as explained at length in his letter. Hutson argued that a soil evaluation is not needed since this is a Minor Subdivision. The Committee voted to recommend approval to full Board of the Final Plat with the stipulation that a soil evaluation analysis be made and approved by Craig Bussman. The Jersey County Ordinance was not discussed and was put on the Agenda for the September 27, 2006 meeting. Motion by Bacon, seconded by Wiggins, to approve the minutes as presented. All in favor, motion carried.

Thomas discussed the minutes of the September 6, 2006, **Finance Committee** meeting. The Committee voted to forward a letter to the Chief Judge of the Judicial Circuit requesting an increase of the Court Security Fee from \$15.00 to \$25.00. The matter of the Schuette Design Study was tabled. The Committee voted to recommend to the full Board the acceptance of the Resolution that the Highway Department begin paying its IMRF employer obligation effective September 1, 2006. A summary of the Employee Health Insurance was distributed. The revenue to date is \$38,781.66 and the expenditures are \$45,758.04. This indicates a total balance of a minus \$3,976.34. Board Chairman Manar addressed the Committee regarding the proposed revenue in the amount of \$7,097,000.00 as well as a hand-out explaining discussing the proposed revenue by line item for fiscal year 2006-2007.. The Committee voted to recommend to the full Board approval of the proposed General Fund Budget in the amount of \$7,097,000.00. Motion by Thomas, seconded by Lux, to approve minutes as reported. All in favor, motion carried.

Chairman of the Finance Committee Thomas, advised that revenue was flat and is expected to increase less than 1% in 2006-2007. This fiscal year intergovernmental loans were used to pay IMRF. The Tax Levy pays for employees' health insurance benefits. Kiel was concerned about the Highway Department having fewer funds for road projects by paying their own IMRF. When questioned if IMRF is included in the PTELL rate. County Clerk Zippay stated "IMRF is included in the PTELL limiting rate." The levy for IMRF was never intended to pay IMRF for the County Highway Department. Chairman Manar said the General Fund will be paid back immediately for the IMRF loan. He also stated these things must be monitored better and with more oversight. Preliminary work also needs to be done on the Tax Levy.

REPORTS OF SPECIAL COMMITTEE

Manar reported on the August 21, 2006 Health Insurance meeting and the savings this past fiscal year on the new health insurance program. The deadline for submitting insurance proposals has been extended to September 15, 2006. Due to the success of the committee this past fiscal year, the Finance Committee is seeking a recommendation from the Special Committee on Health Insurance regarding the increase in co-pays in the current plan. The Committee will meet again for ongoing discussion of insurance issues. Motion by Coatney, seconded by Pratt, to approve minutes as written. All in favor, motion carried.

At this time Lance Jubelt objected to replacing the Docket Entry Clerk when the Judges' Secretary, who also runs the Law Library and helps with docket entries, retires. He stated this would "save the salary of another person. "We should at least look at one person rather than two like it used to be." Chairman Manar stated the

2006-2007 budgets "does not include any layoffs." He said Judge Koval appeared before the Finance Committee and there is also a letter from Judge Koval in their Board packets. Judge Koval stated, "These two jobs have always been there. They were never done by one person. One person could not do it all and one person should not be expected to do the work of two people." Jubelt questioned what went on in other circuit court offices and Koval stated he did not know what went on in other offices, but "in Macoupin two people were needed." Manar stated when they went through the budgets and he met with certain County Officials, if there was an anticipated opening it would not be filled. Manar stated that this action took place prior to today and is funded and also that the County Clerk and County Treasurer were not happy that their positions were not going to be filled. Jubelt stated, "We should treat everyone alike and openings should be looked at in the same way."
