

**ADJOURNED MEETING OF THE MACOUPIN COUNTY BOARD**

**MINUTES**

**JANUARY 9, 2007**

The Adjourned meeting of the Macoupin County Board was called to order Tuesday, JANUARY 9, 2007, at 1:00 p.m. The meeting opened with the Pledge of Allegiance to the Flag. There were twenty-seven members present.

**MINUTES**

Motion by Coatney, seconded by Thomas, to approve the minutes of the December 12, 2006, meeting. All in favor, motion carried.

**GUESTS**

Craig Bussman, Public Health Department, informed the Board the EPA is holding hearing on the sampling of discharge from private property. Last February the Board passed a resolution opposing the samplings. Bussman went to one hearing and is planning on attending additional ones.

Larry Pfeiffer, Regional Superintendent of Schools, presented the Annual Report for the REO office. Pfeiffer explained by State statute his office is required to report to the County Board quarterly on the expenditures and duties of the office which he also distributed.

Buzie Bertagnolli, Animal Control Administrator, introduced Jennifer Schafer, Manager of the Carlinville Wal-Mart. Ms. Schafer presented a grant in the amount of \$1,000 to Bertagnolli for to use toward the Animal Control Building. The grant was voted on by the associates at the local store.

Assistant State's Attorney Brent Cain informed the Members of the County Board that Union Pacific Railroad is petitioning the Illinois Commerce Commission to close a railroad crossing in Nilwood Township on Green Ridge Road. The Commerce Commission will be holding a hearing

regarding this closure on February 1 in Springfield. Cain advised the Board Members that letters and petitions need to be sent to the ICC in opposition and explain the inconvenience it will cause the citizens in the area. Tom Reinhart met with Cain and the Nilwood Township Commissioner as to the action that needed to be taken.

Paula Robinson, U of I Extension Office, distributed a flyer on upcoming Tele-Institute workshops to be held at the Carlinville office. Robinson distributed an informational booklet to the new County Board Members.

## **COMMITTEE REPORTS**

Goodman read the minutes of the December 18, 2006, **Road and Bridge Committee** meeting. The Committee approved and accepted the low bidders for the MFT rock letting. Harding requested a list of the bids that were awarded. Motion by Goodman, seconded by Pratt, to approve the minutes as read. All in favor, motion carried.

Coatney read the minutes of the December 20, 2006, **Sheriff's Building and Grounds Committee** meeting. Sheriff Albrecht updated the Committee on the status of the County landfill. The Committee directed Sheriff Albrecht to put ads in the newspapers to notify the public that it is private property and that trespassers will be prosecuted. The Sheriff reported to the Committee on the inmate medical contract and the agreement for Inmate Health Services. The annual savings for the last two years has been approximately \$38,000 each year. Courthouse Access which is a safety issue was also discussed and an ordinance is being drafted for the Committee's approval. Sheriff Albrecht discussed the video arraignment program which allows a prisoner, who must appear before a judge in the Courthouse, to be videoed/recorded in a room at the jail. It makes it possible for inmates, who must be arraigned, to remain at the jail and transportation would not be necessary. The Committee discussed the website development. Maintenance of the Courthouse was discussed and due to the age of the building. The Sheriff is researching the possibility of grants for repairs of the Courthouse. The budget for the Sheriff's Department, Jail and Courthouse were discussed. Motion by Coatney, seconded by Vojas to approve the minutes as read. All in favor, motion carried.

Chairman Manar, read the minutes of the **Liquor Control Committee** meeting from December 28, 2006. Manar noted that the minutes should read that Kell-Corp has recently leased Timber Lakes Golf Course and that the Committee approved the County Liquor License through June 30, 2007. Motion by Vojas, seconded by Pratt to approve the minutes with the correction from "purchase" to "lease" the golf course. All in favor, motion carried.

Goodman read the minutes of the January 2, 2007, **Road and Bridge Committee** meeting. The Committee approved the claims for December 2006 and approved a 50/50 petition for South Otter #17 in the amount of \$3,000 with the county's portion being \$1,500. The Committee discussed the status of other road and bridge projects that are on going. Motion by Goodman, seconded by Wieseman, to approve the minutes as read. All in favor, motion carried.

Motion by Quirk, seconded by Bellm to appoint Robert Quarton to fill the term of Carlos Christopher to the West Central Development Council Board effective January 9, 2007. All in favor, motion carried.

Motion by Schwallenstecker, seconded by Zirkelbach, to re-appoint Deno Filipinni to the Unit 7 Fire District for a period beginning the first Monday in May 2006 and ending on the first Monday in May 2009. All in favor, motion carried.
